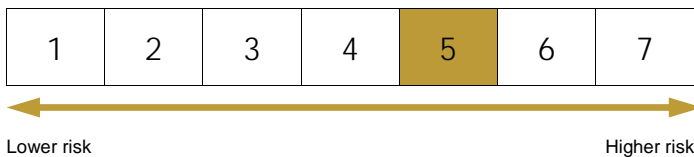

### WHAT IS THIS PRODUCT?

TYPE:	This Product is an Alternative Investment Fund
OBJECTIVES:	The investment objective of Alpha Elite - Active Equity Fund II is to provide investors with long-term capital appreciation by optimising the relationship between risk and return through investment mainly in Investment Funds pursuing alternative investment strategies. The Investment Manager intends to pursue the investment objective by investing in Investment Funds managed by world class investment managers. To achieve its objective it will invest in a portfolio of Investment Funds that the Investment Manager considers to be the most appropriate in various sectors and markets. The strategies employed by these Investment Funds (certain of which may be established as exchange-traded funds) may include (but are not limited to) equity long/short, equity market neutral, event driven, relative value, merger arbitrage and distressed investments strategies.
INTENDED RETAIL INVESTOR:	The Product is targeted at Eligible Counterparties, Professional Clients and Retails Clients (only where retail clients meet the Irish Qualifying Investor criteria). The investor's objective for this investment should be aligned with that of the Product as outlined above.

### WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?



#### RISK INDICATOR

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified the risk classes of the underlying investment strategies as ranging from 5 out of 7, which is a medium-high risk class.

Please note the Sub-Fund is subject to market fluctuations. There is no assurance that any appreciation in the value of investments will occur or that the investment objective of this Sub-Fund will be achieved. The SRI classification is based on the Sub-Fund's liquidity profile & diversification.

The risk indicator assumes you keep the product for 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less. The underlying funds may include illiquid assets such as alternative funds, real estate funds and/or non-quoted assets. These assets incur additional risks which are not considered in the indicator shown above when they do not represent a significant part of the underlying funds. These risks are that these assets could not be sold or not sold at the desired time and / or lead to significant losses. ## WHAT ARE THE COSTS?

### COSTS OVER TIME

The Reduction in Yield (RIY) shows what impact the total costs you pay will have on the investment return you might get. The total costs take into account one-off, ongoing and incidental costs.

The amounts shown here are the cumulative costs of the product itself, for three different holding periods. They include potential early exit penalties. The figures assume you invest 10,000 EUR. The figures are estimates and may change in the future.
